PFS &CA 'Club 50'
Terms and Conditions 2024/2025

1. The name of the draw is PFS & CA 'Club 50' ("the lottery") regardless of the number of members.
2. The purpose of the lottery is to raise funds for the sole benefit of PFS & CA.
3. The Promoter, Sarah Barratt, appointed by PFS&CA will administer the Lottery.
4. There shall be one draw made in each calendar month. Monthly prize-winning numbers will be drawn in the following order: 1st, 2nd, 3rd, 4th prize. 50% of the total monthly subscriptions will be paid out in the form of cash prizes. The lottery shall run continuously from 1st September 2024 and the first draw shall be by the 29th September 2024.
5. The remaining 50% of the net payments will be allocated to the PFS & CA.
6. The subscription to the 'Club 50' shall be £96 per year, payable in advance by cheque before 18th September 2024. Standing orders of £8 per month by direct bank transfer can be arranged, details available on request from PFS&CA.
7. Membership of the Club 50 is open to parents, staff and governors of PFS & CA and their family and friends. All members must be aged 16 or over at the time of joining. PFS & CA members are eligible to join.
8. Members may have multiple subscriptions.
9. Members will be notified of their allocated number via their chosen communication during the first month of the scheme, once payment has been received and prior to the first draw of the year.
10. The draws will be held towards the end of each month in the school playground. Draws will be held in the presence of two independent witnesses and at least two PFS & CA members.
11. Draw results will be emailed to Club 50 members and posted in the school newsletter, village newsletter and displayed on the school noticeboard.
12. Participants may cancel their entry in the Lottery on the 1st September of each year by giving one month's written notice to the Promoter (by 1st August). New members may apply to join at any time during the year by completing an application form and joining the waiting list. Their application will become active on the 1st September each year. Any decision by the PFS&CA to end the Lottery will be on the 1st September by one month's notice to all participants.
13. The Lottery is intended to be a Small Society Lottery under the provisions of the Gambling Act 2005 section 19.
14. The decision of the PFS & CA 'Club 50' committee shall be final in all matters requiring adjudication. The PFS & CA 'Club 50' committee shall also have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the 'Club 50' members as is necessary.
